Výzvy 2014-2015: hodnotenie

- **Prvá spätná väzba z výziev programu H2020 v 12 oblastiach za 18 mesiacov:**
 - 73 000 podaných projektov, „success rate“ klesol z cca 18% v 7RP na 12% v H2020 – viac účastníkov, viac SMEs a iných subjektov; ale: UMB – uspešná
 - 85% všetkých pridelených financí získali inštitúcie v 7 štátoch: UK, Nem., Fr., Tal., Špan., Hol. a Belg.!!!
 - Z 20 najúspešnejších inštitúcií: 9 z UK, 3 Hol., 2 Dán., 2 Belg., 1 z Nem., Tal., Švéd. A Švajč.
 - Potreba nových hodnotiteľov (momentálne cca 60 000 expertov v databáze)
