# **European prize for social integration throughout sport**

Rules 07/2015

#### Article I:

The SPORT+ 'European prize for social integration through sport' project is led by the European Forum for Urban Security (Efus) and its five partners: ASBL Fan Coaching-Eurofan, Zaragoza University, Italian Forum for Urban Security (FISU), The Netherlands Institute for Sports and Physical Activity (NISB), Intituto Superior de Ciências Policiais e Segurança Interna (ISCPSI).

The main objectives of the project are to:

- exchange innovative practices on how to strengthen communities and convey messages of respect, prevention and anti-discrimination through sport in cooperation with sporting organisations;
- develop locally-based cooperation practices between municipalities' services, strengthening cooperation between sport and security services;
- involve local partners in building local strategies for social inclusion through sport.

#### Article II:

The prize consists of:

- five, €8,000 prizes one for the winner of each category;
- highlighting good practices by holding local events, producing a guide, videos and other materials;
- holding a press conference during each event in order to provide better visibility for the prize.

# **Application Procedure**

#### Article III:

The Prize is open to various organisations (local authorities, other local government departments, associations, NGOs, private organisations...) whose action is specific to promoting social inclusion through sport.

## **Article IV:**

Action, in this instance, means any innovative and sustainable measures and/or tools whose effects can be easily measured.

#### Article V:

The local event should take place before EURO 2016 (i.e. anytime between January and June 2016).

#### **Article VI:**

In order to participate, the applicant must complete the following <u>application form</u> before the deadline of the **6th NOVEMBER 2015**, **00:00 CET**.

A Word version of the application form is available upon request and must be sent to Efus by email at napolano@efus before the deadline.

Only applications written in English or French will be considered.

#### Article VII:

Efus' technical team and the partners will examine whether or not the application is acceptable with regards to the selection and evaluation criteria as listed in the Call for Proposals.

To be admissible, the application must respond as completely as possible to the questions in the application form without exceeding the maximum word count in each instance.

You will receive an acknowledgement of receipt from Efus after your application has been received. Candidates who have not received this acknowledgment a week after having submitted their application should contact Efus on +33 1 40 64 49 00.

#### The Selection Panel

# **Article VIII:**

The jury is formed of six members - Efus and the five partners - who were all chosen according to their experience within the fields of sport, security, prevention and social inclusion. The jury is led and coordinated by Efus.

#### Article IX:

The jury will be aided by the Support Committee, a separate voluntary committee, during the initial shortlisting stage. Together they will select which applications will remain in the competition. The jury and Support Committee reserve the right to decline any candidate, or to ask them for any additional information that may be considered necessary.

## **Article X:**

Each member of the jury will have one vote and the partnership will hold the final decision.

#### Article XI:

The jury's decisions will remain confidential. All decisions are final and cannot be contested.

# Award Ceremony for the 'European prize for social integration through sport'

#### Article XII:

There will be a prize ceremony.

# **Article XIII:**

The winner guarantees their presence at one of the award ceremonies. He/she also agrees to attend events organised by the Forum which aim at promoting the action.

# **Article XIV:**

The actions presented through the projects in the 'European prize for social integration through sport' may be reproduced by Efus or the partners for the rewriting of the application form's contents.
